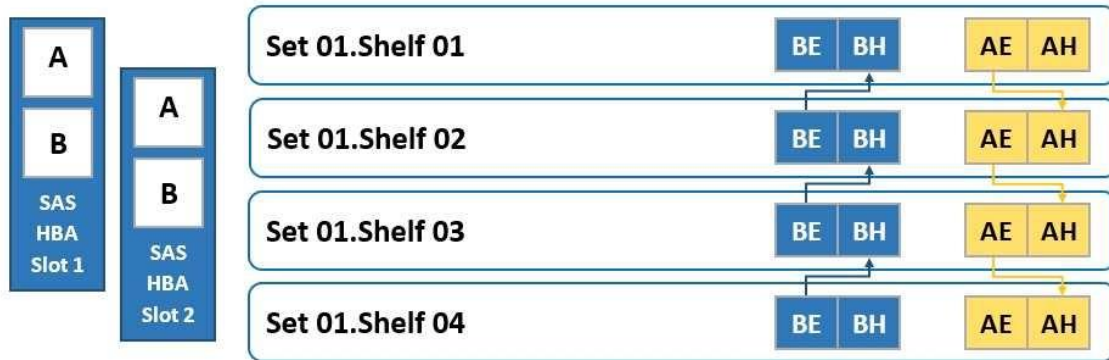

The DS60 ships with 60 drives installed. Depending on the capacity license applied to the PowerProtect DD system either 15, 30, 45, or 60 drives will be accessible.

**Explanation:**

DD VTL supports storing the VTL vault on Cloud Tier storage. To use this functionality, the protection system must be a supported Cloud Tier configuration, and have a Cloud Tier license in addition to the VTL license.

What is the most likely cause of this behavior?

**Explanation:**

While the PowerProtect DD appliance is in restricted mode, the active tier storage is available for backup operations, but I/O on the cloud tier storage is not permitted. The following operations are not permitted while the migration is in progress:

- Sending active tier data to cloud tier storage.
- Recalling data from cloud tier storage.
- Cleaning the cloud tier storage.
- Restoring files directly or reading from the cloud tier storage.
- File system cleaning on the source system.
- System sanitization cannot be performed on the source system.
- Enabling or disabling file system encryption.
- Enabling, disabling, or setting the embedded key manager or an external key manager.
- Creating, destroying, deleting, or syncing keys from the embedded key manager or an external key manager.
